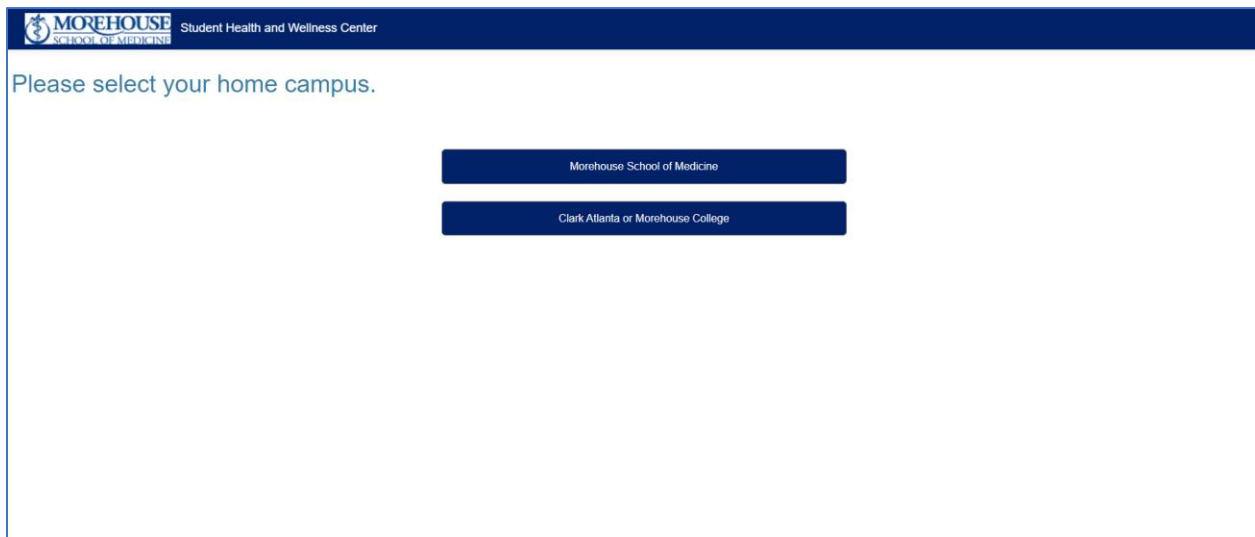


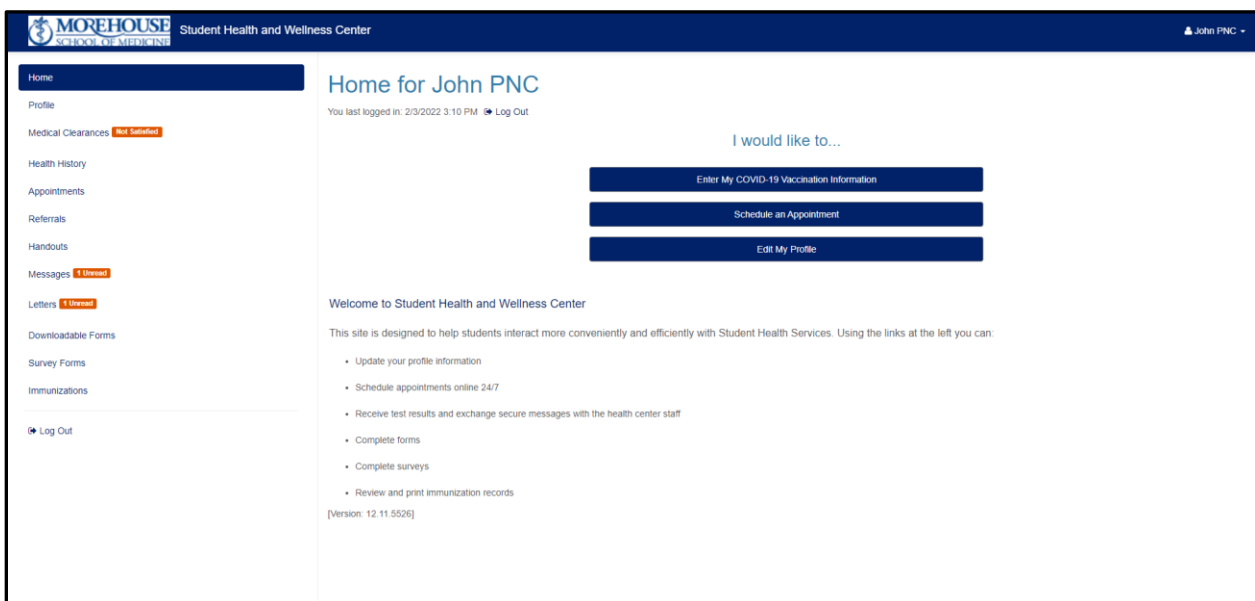
How to Upload Immunization Records to Point and Click (PNC) Patient Portal

Morehouse College

1. Sign into the portal at: <https://MSMPortal.pointnclick.com>. Click on the button that says Clark Atlanta or Morehouse College and log in.
 - **If you have not yet activated your account, please see instructions on how to activate your first.**



2. You will then see the home page. Below is an example of a test patient.



3. Click on the tab on the left side menu called Medical Clearances

Medical Clearances for John PNC

To be fully compliant with your medical clearances, you must make sure you have done the following:

5. Enter the date(s) the requirement was met. Any special instructions will appear at the top of the screen in the blue box. Below is an example of the hepatitis B requirement.

Hepatitis B

This compliance can be satisfied for non-clinical students by 3 HepB containing immunizations OR a Hep B Surface Antibody blood test. MSM clinical students need BOTH the vaccine series AND a Quantitative Hepatitis B surface antibody test

Next click on “Immunization Records” on the same Medical Clearances page to upload any lab results, physical forms, or vaccine records. *Original documents must be uploaded to this tab so that the dates entered to be verified. Entering the dates without original documentation will result in the clearance being marked non-compliant.*

Medical Clearances for John PNC

To be fully compliant with your medical clearances, you must make sure you have done the following:

7. Once reviewed, you will either see the status change to compliant if the requirement is satisfied, or you will receive a message in your portal from the SHWC staff with any additional information required.
8. If you would like to request an exemption form for vaccination requirements, they may be found under “Downloadable Forms.” Please make sure the forms are completed in their entirety. Partial forms or other letters written will not be acceptable. Exemptions are valid for 1 year.
